Effective as of April 1, 2021, Municipal Assurance Corp. ("MAC") merged with and into its affiliate, Assured Guaranty Municipal Corp. ("AGM"), with AGM as the surviving corporation. No action is required of you. MAC's financial guaranty insurance policy listed below remains in full force and effect. As the surviving corporation of the merger, AGM has assumed, by operation of law, all of MAC's liabilities and obligations to policyholders. All other terms, conditions and benefits of your policy remain unchanged, and your rights are not affected, by the merger.
